ACKNOWLEDGMENT OF RISK - RELEASE OF LIABILITY & PARTICIPANT AGREEMENT @ JUMPIN JACKS/REY & LEW ADVENTURE. I, for myself and/or the participant(s), and or heirs, assigns, administrators, personal representatives, and the next of kin, hereby release and hold harmless Jumpin Jacks, their affiliates, officers, members, agent, employees, other participants, and sponsoring agencies from and against all claims, injuries, liabilities, or damages arising out of or related to participation in any and all Jumpin Jacks, activities, parties, the use of the play area and/or inflatable equipment. or resulting from my voluntary attendance/participation at JUMPIN JACKS, or the voluntary attendance/ participations of those for whom I have signed below; and I, for myself, and/or as parent, legal (court appointed) guardian or custodian, willingly agree to comply with the stated and customary terms, rules, and conditions for attendance/ participation, I, for myself, and/or as parent, legal (court-appointed) guardian or custodian, have carefully read the above participation agreement, assumption of risk acknowledgment and release of liability, hereby agree to be bound by it for myself and all minor participants listed below, and fully understand its contents.
